EAHL 2009 - End of Year Round-up

Reflections and Predictions

What a year 2009 has been! The EAHL has been working hard to increase memberships, to organise the 2009 conference - which was a great success! - and to work on ways in which we can help our members get the most out of the Association. We are delighted to say that the Association now has over 90 members across Europe and our membership cohort now includes members from 23 countries across Europe. The 2009 conference played a big part in aiding the Association membership and we would like to thank all those who attended or helped in any way to make the conference such a worthwhile event for everyone.

The three Working Groups have been steadily increasing their work and some very useful ideas came out of the meetings during EAHL 2009 to move these forward. These will be implemented in 2010. One of the main changes to the Association in 2010 will be a new, privately owned website. This will enable us to have much more interactive capabilities and allow our members to exchange information, documents and chat as part of a Working Group or Research Network of the Association.

It only remains to say that we wish everyone a very happy holiday season and look forward to working with you in the New Year.

EAHL Conference 2009

The European Association of Health Law (EAHL) held its second conference at the Royal College of Physicians, Edinburgh on 15th and 16th October 2009. It was attended by over 110 delegates from 23 countries. The conference was generously sponsored by the British Academy and the AHRC. The event was preceded by a public debate on Assisted Dying (please see report below).

Thirty-eight (38) excellent papers were presented where were timely and well received; lively discussions followed each. Eighteen (18) outstanding posters were presented by Early Career Researchers and Postdoctoral Students. Delegates voted over the two days of the conference on the best entry. The winner of the Early Career Researcher competition was Jessica Wright (Sheffield University), and the winner in the Postdoctoral candidate category was Sarah DeFloor, (Leuven University). Congratulations to both!!!

Four (4) keynote speeches were given by distinguished colleagues across Europe which drew together the themes of the conference at the European and international levels and identified ways forward for health lawyers, and more particularly the EAHL. Prof. dr. Henriette D.C. Roscam Abbing (Emeritus Professor of Health Law, University of Utrecht, Vice-president of the EAHL) spoke on *Patients' rights in a technology and market driven Europe*; Dr Anne-Maree Farrell (School of Law, University of Manchester) on *Governing risk: examining the politics of EU regulation of human material;* Professor Mette Hartlev (Professor of Health Law and Bioethics, University of Copenhagen) on *Diversity and Harmonisation in European Health Law - Trends and Challenges;* Professor Toma Birmontiene (Professor of Law, Mykolas Romeris University, and Judge of the Constitutional Court of Lithuania) on *The Development of Health Law as a Way to Change Traditional Attitudes in National Legal Systems. Influence of International Human Rights Law, What is Left for the National Legislator?*

The Conference also provided an opportunity to discuss governance issues and a General Assembly was held on 15th October. A breakdown of the points from this meeting can be found on page 3. Lunch on the second day was organised around the Association's Working Groups: Research & Funding; Teaching & Training; and Institutions. Each Working Group identified key action points which were reported back to the afternoon's plenary session. Further information on these discussions can be found on pages 4 and 5.

The Conference Dinner was held at the Royal College of Surgeons and attendees were treated to a tour of the Royal College's Medical Museum, and traditional Scottish music, performed by The Cosmic Ceilidh Band.

PUBLIC EVENT REPORT

Should we legalise euthanasia and assisted suicide? Lessons from across Europe

The conference was launched with a free public event on the evening of 14 October. Experts from across Europe gave brief presentations on the issues around euthanasia and assisted suicide and the floor was then opened for debate. The panel, chaired by Professor Graeme Laurie, included Prof dr. Henriette Roscam-Abbing (The Netherlands) and Prof Mette Hartlev (Denmark), both keynote speakers at the conference; Prof Herman Nys (Belguim), a member of the EAHL Executive Committee; Dr Roberto Andorno (Switzerland), a presenter at the conference; and Prof Kenneth Boyd (Scotland), a professor of medical ethics at the University of Edinburgh.

The event prompted a lively discussion, and raised a number of interesting and important questions. The informative function of the Journal on legal development at national level will also be strengthened. To this end, a network of national contact points will be established by professor Nys, who will join the team of editors in 2010.

General Assembly outcome

The 2nd General Assembly of the EAHL met at 16:00 on 15th October 2009. Here we summarise what was discussed and agreed at the meeting.

- 1. The Chair informed the General Assembly that Salla Lötjönen and Dominique Sprumont are retiring from the Executive Board. He thanked them for all their work. Three new members of the Executive Board were introduced to the General Assembly for approval. Lukáš Prudil (Czech Republic), Nils Hoppe (Germany) and Oddný Mjöll Arnardóttir (Iceland), were approved as the new members of the Executive Board.
- 2. The General Assembly voted on the Budget Approval method, voting for the Budgets for 2009 and 2010 to be reported at the next GA in 2011. A Budget Committee was presented for approval, with Solvita Olsena (Latvia), Sjef Gevers (Netherlands) and Guilherme D'Oliviera (Portugal) being approved as the Budget Committee for the 2011 Budget report.
- 3. The Activity Report for 2009 was presented to the GA. Members were asked for suggestions for improvements or additions to the work of the EAHL and were informed if they had any suggestions to contact Simone Hull (Simone.Hull@ed.ac.uk).
- 4. The Board informed the GA that one of the EAHL's prime directives was the establishment of three Working Groups, and that these were not progressing as we might have hoped. To help move these forward the lunch on day two of the conference would be dedicated for each of the Working Groups to meet and discuss ideas for improvement. Each Member responsible for the working group gave a brief summary of what the Working Group should be trying to achieve and where they thought improvements could be made. Further details on this can be found on pages 4 & 5.
- 5. The Board announced that the next EAHL conference would be held in 2011 in Leuven, Belgium. It will be hosted by the University of Leuven on 6 and 7 October. The Board invited proposals for themes and informed members that if they wished to be involved in the organisation of the conference to contact Herman Nys (Herman.Nys@med.kuleuven.be) or Simone Hull (Simone.Hull@ed.ac.uk). We encourage all readers to do the same.

6. AOCB

Members suggested that when people attend conferences of events related to the work of the EAHL, they should promote the Association. They asked for publicity materials to be made available for this purpose. The Board assured members that they would action this point.

A suggestion was made and well received for an EAHL Lecture series to be held across Europe. See further details on page 7.

Anne-Marie Duguet informed the Board that the Toulouse Summer School would be taking place again in Summer 2010, and invited suggestions from members for EAHL based workshops for the event. Members should contact (aduquet@club-internet.fr) with suggestions for this.

Working Groups Update

The Association's three Working Groups met on 16th October to discuss the future directions of the group. Below is the summary of the Working Group's discussions.

Institutions

European institutions have great impact on health law. Health law in Europe is also influenced by world based organisations (e.g. UNESCO, WHO, OECD). The "Europeanization" of health law is an ongoing process with health law systems increasingly becoming more closely connected. There is a growing need to have the voice of health lawyers heard at the European level. European institutions are therefore a focal point of attention for the Association.

The Institutions Working Group was setup to maintain a watching brief on European and international institutions whose work has a direct impact on health law and policy in Europe and where input from the Association might have a significant role to play.

Teaching and Training

The Working Group on Teaching and Training agreed that a very valuable and important step in progressing its work would be the establishment of a web portal to allow and to facilitate the exchange of ideas, materials and experiences with respect to teaching and training of health law around Europe. This will be particularly valuable for colleagues in Eastern Europe where access to materials or ideas for curricula for teaching health law is difficult. This recommendation was echoed by the other Working Groups and a decision was taken by the Board, and ratified by the General Assembly, to build such a web portal for EAHL.

Discussion in the Working Group also focussed on the challenges of teaching health law to diverse groups across very wide geographical areas. A proposal was put forward that distance learning might be one way in which these challenges could be addressed, and Graeme Laurie gave the example of the distance learning platform currently being used in the University of Edinburgh to deliver Continuing Professional Development courses and a Masters degree in Law and Medical Ethics. It was agreed that the Working Group should explore the possibility of developing a distance learning module on *European Health Law* with contributions from members around Europe. News of Health Laws across Europe

As part of the Association's overarching purpose to bring together health lawyers from around the Council of Europe to discuss and collaborate on issues of importance in the development of health law and policies, we will be keeping members informed of new laws passed in Europe related to the field of health law. Here are a few that have occurred in recent months.

Patient Rights in Poland

A new Act of 6 November 2008 on Patient's Rights and the Commissioner for Patient's Rights 2008 (the PR Act 2008), came into force in Poland on 21 May 2009. This new legislation on patient's rights reflects actual trends in medical law in Central-Eastern Europe, i.e. process of enactment of specific regulations addressed directly not to the medical profession but to patients. There is no doubt that the PR Act 2008 contributes to the expected ratification of the Convention on Human Rights and Biomedicine of 1997, signed by the Republic of Poland on 7 May 1999.

10th Anniversary of the Biomedicine Convention

On the occasion of the 10th Anniversary of the Biomedicine Convention (it entered into force on 1st December 2009) a Conference was organised on 3 November 2009 in Strasbourg in cooperation with the Slovenian authorities in the framework of the Slovenian Chairmanship of the Committee of Ministers of the Council of Europe. The EU Charter of Fundamental Rights entered into force

On 1 December 2009, the Treaty of Lisbon entered into force. The Treaty of Lisbon preserves existing rights while introducing new ones. In particular, it guarantees the freedoms and principles set out in the Charter of Fundamental Rights and gives its provisions a binding legal force. It concerns civil, political, economic and social rights.
